



ccNSO Policy Session

PDP Retirement Working Group update

Recap: The goal of this PDP is to develop and recommend policies to the ICANN Board of Directors relating to the retirement of ccTLDs and the review mechanisms for decisions relating to the delegation, transfer, revocation and retirement of ccTLDs.

These issues come down to two fundamental questions. The first one is: what happens to a ccTLD if the country it relates to changes its name or ceases to exist (e.g. USSR or Yugoslavia)? The second one is: what is the appeal mechanism if anyone disagrees with a decision from the ICANN Board related to the status of a ccTLD (e.g. refusal to add a new ccTLD to the root zone)?





Data protection, privacy and access to WHOIS

GAC Discussions on WHOIS and Data Protection Policy

This will be an opportunity to assess progress in the deployment of a Standardized System for Access/Disclosure (SSAD) for gTLD Registration Data, to discuss other relevant developments in terms of ICANN engagement with DPAs, the impact on law enforcement needs and other legitimate users. 

The purpose of this session is to determine how the GAC can help the UASG promote UA readiness for governments, and what the right engagement mechanisms for UASG with the public sector are.


